At the very outset, learned counsel for the applicant has taken the plea that his claim is on account of disability "***Tibia Plafond Fracture with Medial Malleolus Fracture (RT) Operated S 82.3 Z09.0***" because of the accident and he is not claiming any relief for "***Obesity E 66.0 Z 09.0***" and "***Fracture Lateral Condyle Tibia (Rt) Operated***" as shown in the disability report. He was on duty though he had gone outside from unit and there was no Court of Inquiry held.

2. Applicant, Ex Sgt Rakesh Kumar, has filed the present Original Application under Section 14 of the Armed Forces Tribunal Act, 2007, for seeking the following relief (s) :-

(a) *Directions to the respondents for quashing letter dated 14.08.2020 as Annexure A-3 vide which the respondents rejected the claim of disability pension of the petitioner @ 50% as against 40% injury w.e.f. 01.11.2020 as per rounding off benefits as applicable for life;*

(b) *Directions to the respondents to release the disability pension @ 50% against 40% w.e.f. 01.11.2020 as per rounding off benefits as*

*applicable for life with 18% annual interest till payment be made which has not been released willfully; and*

*(c) Issue any other appropriate order or direction which this Hon'ble Tribunal may deem fit and proper under the circumstances of this application;*

3. Relevant facts of the case for adjudication are that the applicant joined the Indian Air Force on 28.10.1997 and discharged from service on 31.10.2020 before completion of normal tenure after rendering 23 years and 04 days of qualifying service in low medical category A4G4 (Permanent). During the course of service, while posted with 7 Wing Air Force, Ambala, when he was coming back to his ibid Unit after repair of his personal motor cycle, he met with road accident when a stray animal (cow) came in front of his motor cycle and as a result of which he sustained injuries. Thereafter, he got admitted in Military Hospital wherein he was downgraded to low medical category A4G4 (Temporary) w.e.f. 07.08.2017 and no Court of Inquiry was held in this regard and the injury of the applicant had been declared as not attributable to military service. At the time of re-categorisation, Medical Board downgraded the applicant to low medical category A4G4 (Permanent) in the year of 2019. Having been placed in low medical category, the applicant was required to give his willingness/unwillingness for further retention in service and the applicant gave willingness to serve in sheltered appointment. However, the Commanding Officer had not recommended his further retention in service and issued discharge order By giving final date of discharge w.e.f 31.10.2020. Before discharge from service, he was brought before the duly constituted Release Medical Board (hereinafter referred as "the RMB") wherein his injury assessed @ 20% for life and held it neither attributable to nor aggravated By military service. The claim of the applicant

for the grant of disability pension was forwarded for adjudication before the authority concerned and rejected the same on the ground that the RMB had declared the disability as neither attributable to nor aggravated By military service with an advice to prefer an appeal before the Appellate Committee within six months from the date of receipt of rejection letter i.e 14.08.2020. The applicant made 1<sup>st</sup> Appeal on 23.11.2020 but in vain. Hence, the present Original application.

4. Learned counsel for the applicant has taken the plea that the applicant sustained injury while he was coming back to Unit after repair of his personal motor cycle and he is entitled to disability pension in accordance with Regulation 153 of the Pension Regulations for the Air Force 1961 (Part-1). Learned counsel for the applicant has also taken the plea that as per Note 2 of Rule 12(f) of Entitlement Rules for Casualty Pension Awards 1982, the applicant is entitled to disability element of disability pension By counting him as on duty. Hence, he is entitled to the grant of disability pension w.e.f. 01.11.2020 @ 20% for life.

5. The Union of India in reply has not disputed the basic facts with regard to date of enrolment, date of discharge and holding of rank as Sergeant at the time of discharge from service but has taken the plea that the applicant was not performing the air force duty at the time of accident took place. He was neither on the way from residence to place of duty or vice versa nor on journey to home town from place of duty or vice versa. Therefore, his disability pension claim has rightly been rejected By the authority concerned.

6. We have heard learned counsel for both the parties and have also gone through the relevant facts of the case.

7. It is admitted fact that the applicant met with an accident while a cow unexpectedly came in front of the motorcycle which resulted the injury. In such a situation, whether it can be said that there is no casual connection between the accident and the military service. This poser has to be answered in the light of the relevant rules and regulations and also the laws applicable.

8. Regulation 153 of the Pension Regulations for the Air Force 1961 (Part-1) provides for grant of disability pension to an individual who is invalided out from service which reads as under :-

*“153. Unless otherwise specifically provided, a disability pension may be granted to an individual who is invalided from service on account of a disability which is attributable to or aggravated By air force service and is assessed at 20% or over.*

*The question whether a disability is attributable to or aggravated By air force service shall be determined under the regulations in Appendix II.”*

9. To substantiate the point in issue, the relevant portion of Note 2 of Rule 12(f) Entitlement Rules for Casualty Pensionary Award, 1982, the applicant is entitled to disability element of disability pension By counting him as on duty. The relevant portion of Entitlement Rules for Casualty Pensionary Award, 1982, Rule 12(f) is reproduced as under :-

**“Note 2.**

*Rule 12(f). An accident which occurs when a man is not strictly ‘on duty’ as defined may also be attributable to service, provided that it involved risk which was definitely enhanced in kind or degree By the nature, conditions, obligations or incidents of his service and that the*

*same was not a risk common to human existence in modern conditions in India. Thus for instance, where a person is killed or injured By another party By reason of belonging to the Armed Forces, he shall be deemed 'on duty' at the relevant time. This benefit will be given more liberally to the claimant in cases occurring on active service as defined in the Army/Navy/Air Force Act”.*

10. For all the reasons hereinabove, this application succeeds and the same is, accordingly allowed. Consequently the impugned order **Annexure A-3** is quashed and set aside. The applicant is entitled to disability pension w.e.f. 01.11.2020 @ 20% with the benefit of rounding off to 50% in terms of the judgement of *Hon'ble Supreme Court* in the case of *Civil Appeal No 418 of 2012 titled Union of India and Others versus Ram Avtar* decided on **10.12.2014** and Union of India is directed to calculate and to pay the arrears of disability pension to the applicant within a period of four months from today failing which the applicant shall be entitled to recover interest @ 8% per annum till realisation of entire amount.

11. This application is, accordingly, disposed of, so also the Misc. application (s) pending, if any.
