In view of the above, it is clear that the application for leave to appeal ought to have been moved within 30 days beginning from the date of decision of the Tribunal. Since the application has been filed beyond that period and no sufficient cause has been shown for the delay of 193 days, so it is barred by limitation and is accordingly dismissed. The order passed by the Tribunal on 03.07.2023 was on the basis of judgment passed by Hon'ble Apex Court in Ex.RECT MITHILESH KUMAR VERSUS UNION OF INDIA & ORS. in Civil Appeal No(s) 16438-16440/2017 decided on 27.10.2017 and Union of India and ors. Vs. P.A.Thomas in SLP (C) 20330/2011, decided on 10.12.2014. Even otherwise, learned counsel for the applicant has not been able to satisfy us that the order dated 03.07.2023 passed by this Tribunal involves point of law of general public importance.
