The applicant is the son of deceased Ex-serviceman namely, Anoop Singh and respondent No.6. Anoop Singh was discharged from service in 2007 and was in receipt of pension. Allegedly, respondent No.6 left the matrimonial home in the year 2009 in the company of one Jaggu Singh. Thereafter, she was disinherited by Anoop Singh. He died in the year 2011. Where after, respondent No.6 has been granted family pension in the year 2015. By virtue of a decree of the Guardian Court the grandmother has been appointed guardian of the applicant in the year 2016. When the applicant submitted a claim for grant of ordinary family pension, Zila Sainik Authorities conducted an inquiry and found that respondent No.6 is alive and is residing alone. She has not remarried. Thus, the claim of the applicant for family pension was rejected in 2019.

Learned counsel for the applicant submits that since Anoop Singh has disinherited respondent No.6, she is not entitled to grant of family pension. However, he seeks time to cite law. Time is also sought to address the Court on the issue of limitation.
