Prayer made by the applicant, Ranjeet Singh, in the application is for conducting his Re-assessment Medical Board. Undisputedly, the facts of the case are that the applicant was in the employment of Armed Forces and had suffered disability during his service and his last Medical Board was held in 2010, wherein his disability was assessed to be 15-19% for life. The applicant seeks holding of his RSMB as his disability i.e. ***"ISCHEMIC CVA RT MCA WITH LT HEMI PERAESIS"*** has worsened and ***MoD letter No. 1(2)/97/D (Pen-C), dated 07.02.2001***, entitles him for the same.

Learned counsel for the Union of India has taken the plea that the disability of the applicant was assessed for the life and there is no fresh ground for RSMB.

As the prayer of the applicant before us is for only conducting his Re-assessment Medical Board which is in accordance with Government of India letter dated 7th February, 2001, as detailed above, and his RSMB is to be done for the same injury which he sustained during the service,

we direct the respondents to get the RSMB of the applicant done for the same injury which occurred during the service, within a period of four months and place a copy of the report of RSMB on the record of the case.

The OA is accordingly, disposed of.
