The applicant has sought the relief of grant of service pension after condoning the short-fall of 29 days in the qualifying service.

After his discharge from the Dogra Regiment, the applicant was re-enrolled in the Defence Security Corps, where he served for 14 years, 11 months and 02 days. He was discharged in Low Medical Category but was not granted the disability pension. Thus, the Original Application No. 2182 of 2016 was filed. The same was allowed vide order dated 25.11.2019. The applicant was held entitled to the grant of disability pension.

The disability pension consists of service element as well as disability element. Thus, it is evident that the applicant is in receipt of the relief being sought in the present application.

The Original Application is, thus, dismissed as being not maintainable.

In the present case, the applicant was discharged from the Defence Security Corps after serving for 14 years, 04 months and 23 days. There was a shortfall of 221 days in the qualifying service. Demand for service pension was not accepted.

Learned counsel for the applicant submits that the case is covered by the judgment dated 01.10.2019 passed by a Full Bench of the Armed Forces Tribunal, Principal Bench, New Delhi in **OA No.1238 of 2016, *Shama Kaur v. Union of India & Others.***

Learned counsel for the respondents is not in a position to refute this argument.

Accordingly, the Original Application is allowed. The respondents are directed to condone the shortfall of 221 days and to grant service pension to the applicant with effect from the date following the date of his discharge. Arrears shall, however, be confined to three years before the date of filing of the Original Application. The said arrears be paid within three months from

the date of receipt of a certified copy of this order by the learned counsel for the respondents/OIC, Legal Cell, failing which they shall carry interest @6% per annum.

Oral prayer for grant of leave to appeal is rejected.

Justice Sudhir Mittal, Member (Judicial)

The applicant claims herself to be the widow of late Havildar Avtar Singh Heer. Her grievance is that despite an application having been submitted, ordinary family pension has not been released in her favour after the death of her husband. Date of marriage is 7th December, 1977.

Husband of the applicant was discharged from the Army on 30.04.1982. Official record annexed with the reply shows that his first wife Nirmal Kaur died on 27.09.1977. It also shows that two children were born out of the wedlock of the husband with Nirmal Kaur. Discharge book-let of the husband, records the applicant as his wife. Same is the position in the pension documents also.

Despite the aforementioned record, the claim of the applicant for grant of ordinary family pension was rejected on the ground that she had married Havildar Avtar Singh Heer before the death of his first wife and accordingly the marriage was invalid in law.

As stated hereinabove, official record shows that the marriage of the applicant took place after the death of the first wife. Thus, the reason for rejection of her claim for grant of ordinary family pension is totally illogical.

In view of the above, OA is allowed. The applicant is held entitled to grant of ordinary family pension being the legally wedded wife of late Havildar Avtar Singh Heer with effect from the date following the date of his death. Arrears shall, however be confined to three years before the date of filing of the OA. Same be released in favour of the applicant within three months from the date of receipt of a certified copy of the order by the learned counsel for the respondents/ OIC, Legal Cell, failing which they shall attract interest @ 6% per annum.

Oral prayer for grant of Leave to Appeal is dismissed.
